NATIONAL TREASURY MANAGEMENT AGENCY (STATE
AUTHORITIES) ORDER 2015

I, MICHAEL NOONAN, Minister for Finance, in exercise of the powers conferred on me by paragraph (j) of the definition of “State authority” in section 7(1) of the National Treasury Management Agency (Amendment) Act 2000 (No. 39 of 2000), and with the consent of the Taoiseach, the Minister for Agriculture, Food and the Marine, the Minister for Education and Skills, the Minister for the Environment, Community and Local Government, and the Minister for Justice and Equality, hereby order as follows:

1. This Order may be cited as the National Treasury Management Agency (State Authorities) Order 2015.

2. The bodies specified in the Schedule are prescribed for the purposes of paragraph (j) of the definition of “State authority” in section 7(1) of the National Treasury Management Agency (Amendment) Act 2000 (No. 39 of 2000).
