EUROPEAN COMMUNITIES (MINIMUM CONDITIONS FOR EXAMINING AGRICULTURE PLANT SPECIES) (AMENDMENT) REGULATIONS 2017

- I, MICHAEL CREED, Minister for Agriculture, Food and the Marine, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972), for the purpose of giving effect to Commission Implementing Directive (EU) 2016/1914 of 31 October 2016¹, hereby make the following regulations:
- 1. These Regulations may be cited as the European Communities (Minimum Conditions for Examining Agriculture Plant Species) (Amendment) Regulations 2017.
- 2. The European Communities (Minimum Conditions for Examining Agriculture Plant Species) Regulations 2004 (S.I. No. 122 of 2004) are amended by substituting in Regulation 2 for the definition of "Directive" (as amended by the European Communities (Minimum Conditions for Examining Agriculture Plant Species) (Amendment) Regulations 2016 (S.I. No. 368 of 2016)) the following-

"Directive' means Commission Directive No. 2003/90/EC of 6 October 2003²as amended by Commission Implementing Directive (EU) 2016/1914 of 31 October 2016;".

3. The European Communities (Minimum Conditions for Examining Agriculture Plant Species) (Amendment) Regulations 2016 (S.I. No. 368 of 2016) are revoked.
