#### S.I. No. 199 of 2019

### EUROPEAN UNION (SEED POTATOES) (AMENDMENT) REGULATIONS 2019

- I, MICHAEL CREED, Minister for Agriculture, Food and the Marine, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972), for the purpose of giving effect to Commission Implementing Decision (EU) 2019/119 of 24 January 2019<sup>1</sup>, hereby make the following regulations:
- 1. These Regulations may be cited as the European Union (Seed Potatoes) (Amendment) Regulations 2019.
- 2. The European Union (Seed Potatoes) Regulations 2016 (S.I. No. 641 of 2015) are amended in Regulation 2(1) by substituting for the definition of "Directive" the following:

"Directive' means Council Directive 2002/56/EC of 13 June 2002<sup>2</sup> (as Council Directive 2003/61/EC of 18 June 2003<sup>3</sup>, amended by Commission Implementing Directive 2013/63/EU of 17 December 2013<sup>4</sup>, Commission Implementing Decision 2014/367/EU of 16 June 2014<sup>5</sup>, Commission Implementing Directive (EU) 2016/317 of 3 March 2016<sup>6</sup> and Commission Implementing Decision (EU) 2019/119 of 24 January 2019), and Commission Decision 2004/3/EC of 19 December 2003<sup>7</sup> (as amended by 2014/105/EU: Commission Implementing Decision of 24 February 2014<sup>8</sup>), Commission Decision 2004/842/EC of 1 December 2004<sup>9</sup> (as amended by Commission Implementing Decision (EU) 2016/320 of 3 March  $2016^{10}$ ), Commission Implementing Directive 2014/20/EU of 6 February 2014<sup>11</sup>, Commission Implementing Directive 2014/21/EU of 6 February 2014<sup>12</sup> and Commission Implementing Decision (EU) 2017/547 of 21 March 2017<sup>13</sup>;".

These Regulations give effect to the provisions of Commission Implementing Decision (EU) 2019/119 extends until 31 March 2024 the period in which Member States may determine the equivalence of seed potatoes harvested in third countries with seed potatoes harvested within the Union.
