## Rules of the Superior Courts (Renewal of Summons) 2019

- 1.—(1) These Rules, which may be cited as the Rules of the Superior Courts (Renewal of Summons) 2019, shall come into operation on the 19<sup>th</sup> day of June 2019.
- (2) These Rules shall be construed together with the Rules of the Superior Courts.
- (3) The Rules of the Superior Courts as amended by these Rules may be cited as the Rules of the Superior Courts 1986 to 2019.
- 2. The Forms No. 1 and 2 in the Schedule shall be substituted for the forms bearing the like numbers respectively in Part 1 of Appendix A to the Rules of the Superior Courts.


