EUROPEAN COMMUNITIES (MINIMUM CONDITIONS FOR EXAMINING OF VEGETABLE SPECIES) (AMENDMENT) REGULATIONS 2020

- I, MICHAEL CREED, Minister for Agriculture, Food and the Marine, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972), for the purpose of giving effect to Commission Implementing Directive (EU) 2019/1985 of 28 November 2019 ¹, hereby make the following regulations:
- 1. These Regulations may be cited as the European Communities (Minimum Conditions for Examining of Vegetable Species) (Amendment) Regulations 2020.
- 2. The European Communities (Minimum Conditions for Examining of Vegetable Species) Regulations 2004 (S.I. No. 121 of 2004) are amended by substituting in Regulation 2 for the definition of "Directive" (as amended by European Communities (Minimum Conditions for examining of Vegetable Species) (Amendment) Regulations 2019 (S.I. No. 305 of 2019) the following-

"'Directive' means Commission Directive No. 2003/91/EC of 6 October 2003² as amended by Commission Implementing Directive (EU) 2019/1985 of 28 November 2019;".

3. The European Communities (Minimum Conditions for Examining of Vegetable Species) (Amendment) Regulations 2019 (S.I. No. 305 of 2019) are revoked.
