EUROPEAN COMMUNITIES (SEED OF FODDER PLANTS) (AMENDMENT) REGULATIONS 2020

I, MICHAEL CREED, Minister for Agriculture, Food and the Marine, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972), for the purpose of giving effect to Commission Implementing Directive (EU) 2020/177 of 11 February 2020¹, hereby make the following regulations:

1. These Regulations may be cited as the European Communities (Seed of Fodder Plants) (Amendment) Regulations 2020.

2. The European Communities (Seed of Fodder Plants) Regulations 2002 (S.I. No. 198 of 2002) are amended in Regulation 2(1) by substituting for the definition of "Directive" (as amended by the European Communities (Seed of Fodder Plants) (Amendment) Regulations 2018 (S.I. No.453 of 2018)) the following:

EXPLANATORY NOTE

(This note is not part of the instrument and does not purport to be a legal interpretation)

These Regulations give effect to the provisions of Commission Implementing Directive (EU) 2020/177 by amending the Annexes I and II to Directive 66/401/EEC as they relate to inspections for Union regulated non-quarantine pests (RNQPs) and measures intended to prevent their presence on seeds of fodder plants for planting.
