### CIRCUIT COURT RULES (CASE STATED) 2020

- 1. (1) These Rules, which may be cited as the Circuit Court Rules (Case Stated) 2020, shall come into operation on the 13th day of August 2020.
- (2) These Rules shall be construed together with the Circuit Court Rules 2001 to 2020.
- (3) The Circuit Court Rules 2001 to 2020 as amended by these Rules may be cited as the Circuit Court Rules 2001 to 2020.
- 2. The Circuit Court Rules are amended by the substitution in Order 62 for rule 5 of the following rule:
  - "5. As soon as the Case Stated shall have been signed it shall be lodged with the County Registrar for transmission to the Court of Appeal."

## EXPLANATORY NOTE

(This note is not part of the Instrument and does not purport to be a legal interpretation.)

This rule rectifies Order 62 rule 5 by substituting "Court of Appeal" for "Supreme Court".
