FOOD SAFETY AUTHORITY OF IRELAND ACT 1998 (AMENDMENT OF FIRST SCHEDULE) (NO. 2) ORDER 2021

I, FRANK FEIGHAN, Minister of State at the Department of Health, in exercise of the powers conferred on me by section 5 of the Food Safety Authority of Ireland Act 1998 (No. 29 of 1998) (as adapted by the Health and Children (Alteration of Name of Department and Title of Minister) Order 2011 (S.I. No. 219 of 2011), the Agriculture, Fisheries and Food (Alteration of Name of Department and Title of Minister) Order 2011 (S.I. No. 455 of 2011) and the Health (Delegation of Ministerial Functions) (No. 3) Order 2020 (S.I. No. 599 of 2020), after consultation with the Minister for Agriculture, Food and the Marine, hereby order as follows:

- 1. This Order may be cited as the Food Safety Authority of Ireland Act 1998 (Amendment of First Schedule) (No. 2) Order 2021.
 - 2. In this Order—

"Act" means the Food Safety Authority of Ireland Act 1998 (No. 29 of 1998);

"Order of 2021" means the Food Safety Authority of Ireland Act 1998 (Amendment of First Schedule) Order 2021 (S.I. No. 152 of 2021).

3. Part III (as amended by Article 4 of the Order of 2021) of the First Schedule to the Act is amended by inserting after "Commission Implementing Regulation (EU) 2020/2236 of 16 December 2020 laying down rules for the application of Regulations (EU) 2016/429 and (EU) 2017/625 of the European Parliament and of the Council as regards model animal health certificates for the entry into the Union and movements within the Union of consignments of aquatic animals and of certain products of animal origin from aquatic animals, official certification regarding such certificates and repealing Regulation (EC) No. 1251/2008." the following Regulations:

Commission Regulation (EC) No. 267/2009 of 1 April 2009 amending Regulation (EC) No. 1295/2008 on the importation of hops from third countries.
