EUROPEAN UNION (CEREAL SEED) (AMENDMENT) (NO. 2)
REGULATIONS 2022

I, Charlie McConalogue, Minister for Agriculture, Food and the Marine, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972), for the purpose of giving effect to Commission Implementing Directive (EU) 2021/1927 of 5th November 2021¹, hereby make the following regulations:

1. These Regulations may be cited as the European Union (Cereal Seed) (Amendment) (No. 2) Regulations 2022.

2. The European Union (Cereal Seed) Regulations 2013 (S.I. No. 217 of 2013) are amended in Regulation 2(1) by substituting for the definition of “Directive” (as amended by the European Union (Cereal Seed) (Amendment) Regulations 2022 (S.I. No. 33 of 2022)) the following:

These Regulations give effect to the provisions of Commission Implementing Directive (EU) 2021/1927 of 5th November 2021 and make provision for the requirements necessary for seeds of hybrid wheat produced by means of cytoplasmic male sterility to be included in Annexes I and II of Council Directive 66/402/EEC
