EUROPEAN COMMUNITIES (MINIMUM CONDITIONS FOR EXAMINING AGRICULTURE PLANT SPECIES) (AMENDMENT) **REGULATIONS 2022**

- I, CHARLIE MCCONALOGUE, Minister for Agriculture, Food and the Marine, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972), for the purpose of giving effect to Commission Implementing Directive (EU) 2022/905 of 9 June 2022 ¹, hereby make the following regulations:
- These Regulations may be cited as the European Communities (Minimum Conditions for Examining Agriculture Plant Species) (Amendment) Regulations 2022.
- The European Communities (Minimum Conditions for Examining Agriculture Plant Species) Regulations 2004 (S.I. No. 122 of 2004) are amended by substituting in Regulation 2 for the definition of "Directive" (as amended by the European Communities (Minimum Conditions for Examining Agriculture Plant Species) (Amendment) (No.2) Regulations 2021 (S.I. No. 752 of 2021) the following-

"Directive' means Commission Directive No. 2003/90/EC of 6 October 2003² as amended by Commission Implementing Directive (EU) 2022/905 of 9 June 2022;".

3. The European Communities (Minimum Conditions for Examining Agriculture Plant Species) (Amendment) (No. 2) Regulations 2021 (S.I. No. 752 of 2021) are revoked.
