COMPANIES ACT 2014 (SECTION 682) REGULATIONS 2023

- I, DARA CALLEARY, Minister of State at the Department of Enterprise, Trade and Employment, in exercise of the powers conferred on me by sections 12(1) and 682(2) of the Companies Act 2014 (No. 38 of 2014) as adapted by the Business, Enterprise and Innovation (Alteration of Name of Department and Title of Minister) Order 2020 (S.I. No. 519 of 2020) and the Enterprise, Trade and Employment (Delegation of Ministerial Functions) (No. 2) Order 2023 (S.I. No. 15 of 2023), hereby make the following regulations:
- 1. (1) These Regulations may be cited as the Companies Act 2014 (Section 682) Regulations 2023.
 - (2) These Regulations come into operation on 1 October 2023.
- 2. The form set out in the Schedule to these Regulations is prescribed for the purposes of section 682(2) of the Companies Act of 2014 (No. 38 of 2014).
