# RULES OF THE SUPERIOR COURTS (ORDER 74) 2023

- 1. (1) These Rules, which may be cited as the Rules of the Superior Courts (Order 74) 2023, shall come into operation on the 1st day of October 2023.
- (2) These Rules shall be construed together with the Rules of the Superior Courts.
- (3) The Rules of the Superior Courts as amended by these Rules may be cited as the Rules of the Superior Courts 1986 to 2023.
  - 2. The Rules of the Superior Courts are amended:
    - (i) by the deletion from Order 74 of rule 94, and
    - (ii) by the deletion from Appendix M of Form No. 54.
